Ron Ranson is an English artist, teacher and author who has recently moved from England to Portland, Oregon. Ron is a seemingly tireless watercolorist with a worldwide teaching reputation. ## ELIGIBILITY

- Artists must be 18 years or older.
- Entries must be original works of art, entirely done by the entrant and executed within the last two years.
- Entries must not be giclées, copies in whole or in part of paintings or photographs by other artists.
- Works produced in workshops or under supervision are not eligible.

## CONDITIONS

- Entries will be judged by digital images only.
- Awards will be judged from original paintings.
- Artists may not substitute another work for an accepted work nor withdraw the work once it is accepted.
- Accepted artists who do withdraw may not enter future PAL shows for two years.
- All entries must be for sale. The Civic Center does not charge any commission.
- Maximum FRAMED dimensions: 30"x40".
- Minimum FRAMED size: at least 12-inches in any dimension.
- Entry fees are nonrefundable.
- PAL reserves the right to refuse, upon arrival, any piece of unacceptable quality not discernible in the digital image. Paintings which do not match the digital image or meet the framing criteria will be refused.

## ACCEPTED WORKS

- Work may be hand delivered or shipped. Instructions will be included in your Acceptance Letter.
- There is a \$20 handling fee for shipped works.
- Accepted work must be sturdily framed and ready to hang, including wire.
- Gallery-wrapped canvas does not require framing as long as the sides are properly finished.
- Shipped works must use plexiglass.
- PAL will reproduce accepted artwork, with granted permission, for promotional uses including websites.
- CDs of accepted works will not be returned.
- While utmost care will be taken in handling artwork, neither PAL nor its representatives nor the Civic Center will be responsible for damage or loss from any cause.

## DIGITAL ENTRY PROCEDURES

- Jpg format maximum size 1024x768 pixels at 72dpi, maximum file size of 500kb.
- Save each image as 'artist name.title of work.jpg' – e.g 'JerryJones.Girl-with-Flowers.jpg'
- Multiple images may be saved to one CD.
- You may submit your image(s) by mail with entry form and entry fee; or email your images to: **palartshow@comcast.net.** Emailed images will not be eligible until entry form and check are received in mail.
